**REGULAR SESSION**

**OLD BUSINESS:**


1. Police Report – Chief Kenny Stewart gave the monthly report, noting that there have been several wrecks on Hwy 19 recently. There was a dump truck left in the middle of Thompson Creek Road this afternoon. The company has been contacted to remove the truck immediately.
2. Fire Report – Fire Chief Jimmy Garig reported that Norwood has been 4 years without a structure fire.
3. Maintenance Report – Kohnke Rogillio reported that there is a trash issue in town. People leave the store and throw their trash out along Hwy 19. He said that they've fixed 4 water leaks since the last meeting.

3. Beer License for S&W Café – A motion was made by Ald. Poole and was seconded by Ald. Jett approving the 2025 Beer License for S&W Café.


