NEW BUSINESS:



2. Budget Proposal 2023/2024 – A motion was made by Ald. Sellers and seconded by Ald. Jett introducing the Budget Proposal Ordinance 2023-2. Public hearing will be held on 6/7/2023 at 5:45 p.m.
3. Marijuana 14 grams or less – Ordinance – A motion was made by Ald. Jett and seconded by Ald. Sellers introducing Possession of Marijuana 14 grams or less Ordinance 2023-3. Public hearing will be held on 7/13/2023 at 6:30 p.m.
